

Regulamin konkursu plastycznego MÓJ MIP

1. The art contest is organized by Fundacja Centrum Badań Migracyjnych (Migration Research Center Foundation) / Migrant Info Point. The name of the contest is MÓJ MIP (MY MIP).
2. The contest is open to children and adults.
3. The subject of the contest is to design a postcard with the theme: What comes to your mind when you think about Migrant Info Point?
4. Size of the artwork: A4.
5. Acceptable artwork techniques: 2D techniques (hand-drawn, digital, collage).
6. The contest will be open to applications physically delivered to the Migrant Info Point office. If the work is done with computer technology, a printout of the work in the appropriate size must be provided.
7. Each work should be legibly signed on the back: name, surname, e-mail, and in case of a minor - additionally - the name of the guardian.
8. Please deliver the works to Migrant Info Point, Poznań, Al. Marcinkowskiego 11, by October 6, 2023.
9. The evaluation of the works will be carried out by a jury appointed by the organizer.
10. The competition committee will select the works (a minimum of 3) that will win the grand prize.
11. The main prize for the author(s) of the best projects is the publication of a postcard in paper form.
12. The results will be announced on the date specified by the organizer, no later than October 15, 2023. The authors/s will be notified of the results by email.
13. The organizer reserves the right to free reproduction of the awarded works, also in the press, catalog, Internet and other publications, as well as the right to make minor modifications to the works for publishing purposes.
14. The organizer declares that each publication of works will be signed with the first and last name of the author(s).
15. Artworks submitted to the competition become the property of the organizer.
16. Taking part in the contest means consenting to the processing of personal data of the participant (in terms of first and last name) and, in the case of underage children, of the guardian (in terms of first and last name) by Fundacja Centrum Badań Migracyjnych based in Poznan, Al Marcinkowskiego 11, 61-827.
